19 SECTION 1. AMENDATORY 57 O.S. 2011, Section 509.2, is

3 ~~B. Due to the unusual circumstance that the facilities named in~~

6 ~~enforcement officer on an ongoing basis, it is the intent of the~~
7 ~~Legislature that the Department of Public Safety shall establish a~~
8 ~~permanent trooper position to be based and stationed in the town of~~
9 ~~Taft Dr. Eddie Walter Warrior Correctional Center are located. The~~
10 ~~agreement shall be approved by the municipality.~~

11 SECTION 2. This act shall become effective November 1, 2019.
