ON PAGE 14, LINES 4 THROUGH 13, by deleting all the new language in paragraph 12;

ON PAGE 16, LINES 18 THROUGH 23, by deleting all the new language and restoring the stricken language in paragraph 16;

ON PAGE 26, LINE 22 THROUGH PAGE 27, LINE 2, by deleting the new language in paragraph 33;

ON PAGE 27, LINES 4 THROUGH 11, by deleting all the new language and restoring the stricken language in paragraph 34;

ON PAGE 45, LINE 15, by adding the following language after the stricken period "." and relettering subsequent subsections:

"An employer which violates any provision of this section shall be liable in a district court action for reasonable damages, actual and punitive if applicable, suffered by an employee as a result of the violation. Exemplary or punitive damage awards made pursuant to this section shall not exceed One Hundred Thousand Dollars, (\$100,000.00). The employee shall have the burden of proof by a preponderance of the evidence."
