AS INTRODUCED

An Act relating to alcoholic beverages; amending Section 13, Chapter 366, O.S.L. 2016, as last amended by Section 2, Chapter 312, O.S.L. 2018, (37A O.S. Supp. 2018, Section 2-101), which relates to fees; modifying language; deleting nonresident seller; modifying certain manufacturer's license fee amounts; providing for designating and nondesignating licenses; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY Section 13, Chapter 366, O.S.L. 2016, as last amended by Section 2, Chapter 312, O.S.L. 2018 (37A O.S. Supp. 2018, Section 2-101), is amended to read as follows:

Section 2-101. A. Except as otherwise provided in this section, the licenses issued by the ABLE Commission, and the annual fees therefor, shall be as follows:

- 1. Brewer License..... \$1,250.00
- 2. Small Brewer License..... \$125.00
- 3. Distiller License..... \$3,125.00
- 4. Winemaker License..... \$625.00
- 5. Small Farm Winery License..... \$75.00

B. 1. There shall be added to the initial or renewal fees for a Mixed Beverage License an administrative fee, which shall not be deemed to be a license fee, in the amount of Five Hundred Dollars (\$500.00), which shall be paid at the same time and in the same manner as the license fees prescribed by paragraph 10 of subsection A of this section; provided, this fee shall not be assessed against

1 service organizations or fraternal beneficiary societies which are  
2 exempt under Section 501(c)(19), (8) or (10) of the Internal Revenue  
3 Code.

4 2. There shall be added to the fee for a Mixed Beverage/Caterer  
5 Combination License an administrative fee, which shall not be deemed  
6 to be a license fee, in the amount of Two Hundred Fifty Dollars  
7 (\$250.00), which shall be paid at the same time and in the same  
8 manner as the license fee prescribed by paragraph 11 of subsection A  
9 of this section.

10 C. Notwithstanding the provisions of subsection A of this  
11 section:

12 1. The license fee for a mixed beverage or bottle club license  
13 for those service organizations or fraternal beneficiary societies  
14 which are exempt under Section 501(c)(19), (8) or (10) of the  
15 Internal Revenue Code shall be Five Hundred Dollars (\$500.00) per  
16 year; and

17 2. The renewal fee for an airline/railroad beverage license  
18 held by a railroad described in 49 U.S.C., Section 24301, shall be  
19 One Hundred Dollars (\$100.00).

20 D. An applicant may apply for and receive both an on-premises  
21 beer and wine license and a caterer license.

22 E. All licenses, except as otherwise provided, shall be valid  
23 for one (1) year from date of issuance unless revoked or  
24

1 surrendered. Provided, all employee licenses shall be valid for two  
2 (2) years.

3 F. The holder of a license, issued by the ABLE Commission, for  
4 a bottle club located in a county of this state where the sale of  
5 alcoholic beverages by the individual drink for on-premises  
6 consumption has been authorized, may exchange the bottle club  
7 license for a mixed beverage license or an on-premises beer and wine  
8 license and operate the licensed premises as a mixed beverage  
9 establishment or an on-premises beer and wine establishment subject  
10 to the provisions of the Oklahoma Alcoholic Beverage Control Act.  
11 There shall be no additional fee for such exchange and the mixed  
12 beverage license or on-premises beer and wine license issued shall  
13 expire one (1) year from the date of issuance of the original bottle  
14 club license.

15 G. In addition to the applicable licensing fee, the following  
16 surcharge shall be assessed annually on the following licenses:

- 17 1. ~~Nonresident Seller or~~ Designating Wine and  
18 Spirit Manufacturer License..... ~~\$2,500.00~~  
19 50 cases or less sold in Oklahoma in last  
20 calendar year ..... \$125.00  
21 51 to 500 cases sold in Oklahoma in the last  
22 calendar year ..... \$250.00  
23 501 cases or more sold in Oklahoma in the  
24 last calendar year ..... \$375.00

2. Wine and Spirits Wholesaler License..... \$2,500.00
3. Beer Distributor..... \$1,000.00
4. Retail Spirits License for cities and towns  
over 5,000 population..... \$250.00
5. Retail Spirits License for cities and towns  
from 2,501 to 5,000 population..... \$200.00
6. Retail Spirits License for cities and towns  
from 200 to 2,500 population..... \$150.00
7. Retail Wine License..... \$250.00
8. Retail Beer License..... \$250.00
9. Mixed Beverage License..... \$25.00
10. Mixed Beverage/Caterer Combination License..... \$25.00
11. Caterer License..... \$25.00
12. On-Premises Beer and Wine License..... \$25.00
13. Annual Public Event License..... \$25.00
14. Small Farm Winery License..... \$25.00
15. Small Brewer License..... \$35.00

The surcharge shall be paid concurrent with the licensee's annual licensing fee and, in addition to Five Dollars (\$5.00) of the employee license fee, shall be deposited in the Alcoholic Beverage Governance Revolving Fund established pursuant to Section 5-128 of this title.

H. Any license issued by the ABLE Commission under this title may be relied upon by other licensees as a valid license, and no

1 other licensee shall have any obligation to independently determine  
2 the validity of such license or be held liable solely as a  
3 consequence of another licensee's failure to maintain a valid  
4 license.

5 SECTION 2. This act shall become effective November 1, 2019.
