17 Department of Mines, the Oklahoma Tourism and  
18 Recreation Department, the Oklahoma Water Resources  
19 Board, the Alcoholic Beverage Laws Enforcement  
20 Commission, the Department of Corrections, the  
21 Oklahoma State Bureau of Investigation, the Council  
22 on Law Enforcement Education and Training, the Board  
23 of Medicolegal Investigations, the Oklahoma State  
24 Bureau of Narcotics and Dangerous Drugs Control, the  
Department of Public Safety, the Office of the  
Attorney General, the Court of Criminal Appeals,  
district attorneys and the District Attorneys  
Council, the Supreme Court, the Oklahoma Indigent  
Defense System, the Pardon and Parole Board, the  
Oklahoma Quick Action Closing Fund, The State  
Emergency Fund, the Rate Preservation Fund, the  
Maintenance of State Buildings Revolving Fund, the  
Digital Transformation Program Revolving Fund, and  
the Multiple Injury Trust Fund; stating amounts of  
the appropriations; stating purposes and  
restrictions; authorizing transfers and deposits; and  
providing effective dates.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

EDUCATION

SECTION 1. There is hereby appropriated to the State Board of  
Education from any monies not otherwise appropriated from the

1 General Revenue Fund of the State Treasury for the fiscal year  
2 ending June 30, 2020, the sum of One Billion Four Hundred Seventy-  
3 eight Million One Hundred Five Thousand Seven Hundred Dollars  
4 (\$1,478,105,700.00) or so much thereof as may be necessary for the  
5 financial support of public schools. Of those funds appropriated,  
6 the State Board of Education shall designate Fifty-eight Million  
7 Eight Hundred Fifty-eight Thousand Five Hundred Three Dollars  
8 (\$58,858,503.00) for increased compensation for certified personnel  
9 as defined by Section 26-103 of Title 70 of the Oklahoma Statutes.

10 SECTION 2. There is hereby appropriated to the State Board of  
11 Education from any monies not otherwise appropriated from the  
12 Education Reform Revolving Fund created in Section 34.89 of Title 62  
13 of the Oklahoma Statutes, the sum of Eight Hundred Fifty-four  
14 Million Three Hundred Thousand Five Hundred Twenty-five Dollars  
15 (\$854,300,525.00) or so much thereof as may be necessary for the  
16 financial support of public schools.

17 SECTION 3. The State Board of Education is hereby authorized to  
18 expend during the fiscal year ending June 30, 2020, from the Common  
19 Education Technology Revolving Fund of the State Treasury, the sum  
20 of Forty-seven Million One Hundred Eleven Thousand Four Hundred  
21 Twelve Dollars (\$47,111,412.00) or so much thereof as may be  
22 necessary for the financial support of public schools.

23 SECTION 4. There is hereby appropriated to the State Board of  
24 Education from any monies not otherwise appropriated from the

1 Mineral Leasing Fund of the State Treasury for the fiscal year  
2 ending June 30, 2020, the sum of Three Million Eight Hundred  
3 Thousand Dollars (\$3,800,000.00) or so much thereof as may be  
4 necessary for the financial support of public schools.

5 SECTION 5. There is hereby appropriated to the State Board of  
6 Education from any monies not otherwise appropriated from the  
7 Mineral Leasing Fund of the State Treasury for the fiscal year  
8 ending June 30, 2018, the sum of One Hundred Thirty-one Dollars  
9 (\$131.00) or so much thereof as may be necessary for the financial  
10 support of public schools.

11 SECTION 6. There is hereby appropriated to the State Board of  
12 Education from any monies not otherwise appropriated from the  
13 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
14 fiscal year ending June 30, 2020, the sum of Twenty-one Million  
15 Three Hundred Seventy-five Thousand Dollars (\$21,375,000.00) or so  
16 much thereof as may be necessary for the financial support of public  
17 schools.

18 SECTION 7. There is hereby appropriated to the State Board of  
19 Education from any monies not otherwise appropriated from the  
20 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
21 fiscal year ending June 30, 2018, the sum of Seven Million Seventy-  
22 eight Thousand Two Hundred Eighty-nine Dollars (\$7,078,289.00) or so  
23 much thereof as may be necessary for the financial support of public  
24 schools.

1 SECTION 8. There is hereby appropriated to the State Board of  
2 Education from any monies not otherwise appropriated from the  
3 General Revenue Fund of the State Treasury for the fiscal year  
4 ending June 30, 2020, the sum of One Hundred Million Nine Hundred  
5 Nineteen Thousand Twenty-six Dollars (\$100,919,026.00) or so much  
6 thereof as may be necessary for the support of public schools  
7 activities.

8 SECTION 9. There is hereby appropriated to the State Board of  
9 Education from any monies not otherwise appropriated from the  
10 General Revenue Fund of the State Treasury for the fiscal year  
11 ending June 30, 2020, the sum of Thirty-three Million Dollars  
12 (\$33,000,000.00) or so much thereof as may be necessary for the  
13 purchase of textbooks and instructional materials.

14 SECTION 10. There is hereby appropriated to the State Board of  
15 Education from any monies not otherwise appropriated from the  
16 General Revenue Fund of the State Treasury for the fiscal year  
17 ending June 30, 2020, the sum of Three Hundred Twenty-two Million  
18 Four Hundred Fourteen Thousand One Hundred Ninety-nine Dollars  
19 (\$322,414,199.00) or so much thereof as may be necessary for the  
20 Certified Employee Health Benefit Allowance.

21 SECTION 11. There is hereby appropriated to the State Board of  
22 Education from any monies not otherwise appropriated from the  
23 General Revenue Fund of the State Treasury for the fiscal year  
24 ending June 30, 2020, the sum of One Hundred Eighty Million Two

1 Hundred Seventy-seven Thousand Seven Hundred Twenty-one Dollars  
2 (\$180,277,721.00) or so much thereof as may be necessary for the  
3 Support Personnel Health Benefit Allowance.

4 SECTION 12. There is hereby appropriated to the State Board of  
5 Education from any monies not otherwise appropriated from the  
6 General Revenue Fund of the State Treasury for the fiscal year  
7 ending June 30, 2020, the sum of Sixteen Million Two Hundred Forty-  
8 six Thousand Ninety-seven Dollars (\$16,246,097.00) or so much  
9 thereof as may be necessary for administrative and support functions  
10 of the State Department of Education.

11 SECTION 13. There is hereby appropriated to the State Board of  
12 Education from any monies not otherwise appropriated from the  
13 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
14 fiscal year ending June 30, 2020, the sum of Two Million Three  
15 Hundred Seventy-five Thousand Dollars (\$2,375,000.00) or so much  
16 thereof as may be necessary for transfer to the School Consolidation  
17 Assistance Fund.

18 SECTION 14. There is hereby appropriated to the State Board of  
19 Education from any monies not otherwise appropriated from the  
20 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
21 fiscal year ending June 30, 2018, the sum of Seven Hundred Eighty-  
22 six Thousand Four Hundred Seventy-seven Dollars (\$786,477.00) or so  
23 much thereof as may be necessary for transfer to the School  
24 Consolidation Assistance Fund.

1 SECTION 15. There is hereby appropriated to the State Board of  
2 Education from any monies not otherwise appropriated from the  
3 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
4 fiscal year ending June 30, 2020, the sum of Two Million Three  
5 Hundred Seventy-five Thousand Dollars (\$2,375,000.00) or so much  
6 thereof as may be necessary for transfer to the Teachers' Retirement  
7 System Dedicated Revenue Revolving Fund.

8 SECTION 16. There is hereby appropriated to the State Board of  
9 Education from any monies not otherwise appropriated from the  
10 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
11 fiscal year ending June 30, 2018, the sum of Seven Hundred Eighty-  
12 six Thousand Four Hundred Seventy-seven Dollars (\$786,477.00) or so  
13 much thereof as may be necessary for transfer to the Teachers'  
14 Retirement System Dedicated Revenue Revolving Fund.

15 SECTION 17. There is hereby appropriated to the Oklahoma Arts  
16 Council from any monies not otherwise appropriated from the General  
17 Revenue Fund of the State Treasury for the fiscal year ending June  
18 30, 2020, the sum of Two Million Nine Hundred Twelve Thousand Five  
19 Hundred Thirty-one Dollars (\$2,912,531.00) or so much thereof as may  
20 be necessary to perform the duties imposed upon the Oklahoma Arts  
21 Council by law.

22 SECTION 18. There is hereby appropriated to the State Board of  
23 Career and Technology Education from any monies not otherwise  
24 appropriated from the General Revenue Fund of the State Treasury for

1 the fiscal year ending June 30, 2020, the sum of One Hundred Thirty-  
2 nine Million Four Hundred Seventy-nine Thousand One Hundred Eighty-  
3 five Dollars (\$139,479,185.00) or so much thereof as may be  
4 necessary to perform the duties imposed upon the State Board of  
5 Career and Technology Education by law.

6 SECTION 19. There is hereby appropriated to the State Board of  
7 Career and Technology Education from any monies not otherwise  
8 appropriated from the Oklahoma Education Lottery Trust Fund of the  
9 State Treasury for the fiscal year ending June 30, 2020, the sum of  
10 Two Million Six Hundred Twelve Thousand Five Hundred Dollars  
11 (\$2,612,500.00) pursuant to paragraph 2 of subsection F of Section  
12 713 of Title 3A of the Oklahoma Statutes for allocation by the State  
13 Board of Career and Technology Education for the education and  
14 general operating budgets of the institutions and for other  
15 programs, construction, renovations or repairs administered by the  
16 State Board of Career and Technology Education.

17 SECTION 20. There is hereby appropriated to the State Board of  
18 Career and Technology Education from any monies not otherwise  
19 appropriated from the Oklahoma Education Lottery Trust Fund of the  
20 State Treasury for the fiscal year ending June 30, 2018, the sum of  
21 Eight Hundred Sixty-five Thousand One Hundred Twenty-four Dollars  
22 (\$865,124.00) pursuant to paragraph 2 of subsection F of Section 713  
23 of Title 3A of the Oklahoma Statutes for allocation by the State  
24 Board of Career and Technology Education for the education and

1 general operating budgets of the institutions and for other  
2 programs, construction, renovations or repairs administered by the  
3 State Board of Career and Technology Education.

4 SECTION 21. There is hereby appropriated to the Office of  
5 Educational Quality and Accountability from any monies not otherwise  
6 appropriated from the General Revenue Fund of the State Treasury for  
7 the fiscal year ending June 30, 2020, the sum of One Million One  
8 Hundred Thirty-two Thousand Five Hundred Nine Dollars  
9 (\$1,132,509.00) or so much thereof as may be necessary to perform  
10 the duties imposed upon the Office of Educational Quality and  
11 Accountability by law. Of those funds appropriated the sum of Sixty  
12 Thousand Dollars (\$60,000.00) shall be deposited in the Teacher  
13 Certification Scholarship Revolving Fund created pursuant to Section  
14 6-187C of Title 70 of the Oklahoma Statutes. Of those funds  
15 appropriated the sum of One Hundred Eighty Thousand Dollars  
16 (\$180,000.00) shall be deposited in the Education Leadership  
17 Oklahoma Revolving Fund created pursuant to Section 6-204.3 of Title  
18 70 of the Oklahoma Statutes.

19 SECTION 22. There is hereby appropriated to the Office of  
20 Educational Quality and Accountability from any monies not otherwise  
21 appropriated from the Special Cash Fund of the State Treasury the  
22 sum of Five Hundred Thousand Dollars (\$500,000.00) or so much  
23 thereof as may be necessary to perform the duties imposed upon the  
24 Office of Educational Quality and Accountability by law.

1 SECTION 23. There is hereby appropriated to the Oklahoma  
2 Educational Television Authority from any monies not otherwise  
3 appropriated from the General Revenue Fund of the State Treasury for  
4 the fiscal year ending June 30, 2020, the sum of Two Million Eight  
5 Hundred Forty-two Thousand Seven Hundred Thirteen Dollars  
6 (\$2,842,713.00) or so much thereof as may be necessary to perform  
7 the duties imposed upon the Oklahoma Educational Television  
8 Authority by law.

9 SECTION 24. There is hereby appropriated to the Oklahoma State  
10 Regents for Higher Education from any monies not otherwise  
11 appropriated from the General Revenue Fund of the State Treasury for  
12 the fiscal year ending June 30, 2020, the sum of Six Hundred Sixty-  
13 six Million Nine Hundred Nine Thousand Three Hundred Sixty-seven  
14 Dollars (\$666,909,367.00) or so much thereof as may be necessary for  
15 allocation by the Oklahoma State Regents for Higher Education  
16 pursuant to the provisions of Article XIII-A of the Oklahoma  
17 Constitution for the education and general operating budgets of the  
18 institutions and for other programs, construction, renovations or  
19 repairs administered by the Oklahoma State Regents for Higher  
20 Education. Of those funds appropriated, the sum of Three Million  
21 One Hundred Twenty-three Thousand Four Hundred Ten Dollars  
22 (\$3,123,410.00) shall be transferred to the Oklahoma Tuition  
23 Equalization Grant Trust Fund to implement the provisions of the  
24 Oklahoma Tuition Equalization Grant Act.

1 SECTION 25. The Oklahoma State Regents for Higher Education are  
2 hereby authorized to expend during the fiscal year ending June 30,  
3 2020, the sum of Forty-seven Million One Hundred Eleven Thousand  
4 Four Hundred Twelve Dollars (\$47,111,412.00) from the Higher  
5 Education Capital Revolving Fund of the State Treasury for  
6 allocation by the Oklahoma State Regents for Higher Education  
7 pursuant to the provisions of Article XIII-A of the Oklahoma  
8 Constitution for the education and general operating budgets of the  
9 institutions and for other programs, construction, renovations or  
10 repairs administered by the Oklahoma State Regents for Higher  
11 Education.

12 SECTION 26. The Oklahoma State Regents for Higher Education are  
13 hereby authorized to expend during the fiscal year ending June 30,  
14 2020, the sum of Forty-seven Million One Hundred Eleven Thousand  
15 Four Hundred Twelve Dollars (\$47,111,412.00) from the Oklahoma  
16 Student Aid Revolving Fund of the State Treasury for allocation by  
17 the Oklahoma State Regents for Higher Education pursuant to the  
18 provisions of Article XIII-A of the Oklahoma Constitution for the  
19 education and general operating budgets of the institutions and for  
20 other programs, construction, renovations or repairs administered by  
21 the Oklahoma State Regents for Higher Education.

22 SECTION 27. There is hereby appropriated to the Oklahoma State  
23 Regents for Higher Education from any monies not otherwise  
24 appropriated from the General Revenue Fund of the State Treasury for

1 the fiscal year ending June 30, 2020, the sum of Eleven Million  
2 Seven Hundred Sixty-four Thousand Eight Hundred Twenty-three Dollars  
3 (\$11,764,823.00) or so much thereof as may be necessary for  
4 expenditures for concurrent enrollment pursuant to Section 628.13 of  
5 Title 70 of the Oklahoma Statutes.

6 SECTION 28. There is hereby appropriated to the Oklahoma State  
7 Regents for Higher Education from any monies not otherwise  
8 appropriated from the Oklahoma Education Lottery Trust Fund of the  
9 State Treasury for the fiscal year ending June 30, 2020, the sum of  
10 Eighteen Million Seven Hundred Sixty-two Thousand Five Hundred  
11 Dollars (\$18,762,500.00) pursuant to paragraph 2 of subsection F of  
12 Section 713 of Title 3A of the Oklahoma Statutes for allocation by  
13 the Oklahoma State Regents for Higher Education pursuant to the  
14 provisions of Article XIII-A of the Oklahoma Constitution for  
15 construction, renovations or repairs administered by the Oklahoma  
16 State Regents for Higher Education or for any other purpose  
17 authorized by paragraph 2 of subsection F of Section 713 of Title 3A  
18 of the Oklahoma Statutes.

19 SECTION 29. There is hereby appropriated to the Oklahoma State  
20 Regents for Higher Education from any monies not otherwise  
21 appropriated from the Oklahoma Education Lottery Trust Fund of the  
22 State Treasury for the fiscal year ending June 30, 2018, the sum of  
23 Six Million Two Hundred Thirteen Thousand One Hundred Sixty-five  
24 Dollars (\$6,213,165.00) pursuant to paragraph 2 of subsection F of

1 Section 713 of Title 3A of the Oklahoma Statutes for allocation by  
2 the Oklahoma State Regents for Higher Education pursuant to the  
3 provisions of Article XIII-A of the Oklahoma Constitution for  
4 construction, renovations or repairs administered by the Oklahoma  
5 State Regents for Higher Education or for any other purpose  
6 authorized by paragraph 2 of subsection F of Section 713 of Title 3A  
7 of the Oklahoma Statutes.

8 SECTION 30. There is hereby appropriated to the Oklahoma State  
9 Regents for Higher Education from any monies not otherwise  
10 appropriated from the General Revenue Fund of the State Treasury for  
11 the fiscal year ending June 30, 2020, the sum of Four Million One  
12 Hundred Ninety-seven Thousand Three Hundred Seventy-nine Dollars  
13 (\$4,197,379.00) or so much thereof as may be necessary for the  
14 general operating budget of the Administrative Offices of the  
15 Oklahoma State Regents for Higher Education.

16 SECTION 31. There is hereby appropriated to the Commissioners  
17 of the Land Office from any monies not otherwise appropriated from  
18 the Commissioners of the Land Office Fund of the State Treasury for  
19 the fiscal year ending June 30, 2020, the sum of Eight Million Seven  
20 Hundred Twenty-eight Thousand Four Hundred Thirteen Dollars  
21 (\$8,728,413.00) or so much thereof as may be necessary to perform  
22 the duties imposed upon the Commissioners of the Land Office by law.

23 SECTION 32. There is hereby appropriated to the Oklahoma  
24 Department of Libraries from any monies not otherwise appropriated

1 from the General Revenue Fund of the State Treasury for the fiscal  
2 year ending June 30, 2020, the sum of Four Million Five Hundred  
3 Twenty-seven Thousand Four Hundred Eleven Dollars (\$4,527,411.00) or  
4 so much thereof as may be necessary to perform the duties imposed  
5 upon the Oklahoma Department of Libraries by law.

6 SECTION 33. There is hereby appropriated to the Physician  
7 Manpower Training Commission from any monies not otherwise  
8 appropriated from the General Revenue Fund of the State Treasury for  
9 the fiscal year ending June 30, 2020, the sum of Six Million Eight  
10 Hundred Thirty-six Thousand Three Hundred Thirty Dollars  
11 (\$6,836,330.00) or so much thereof as may be necessary to perform  
12 the duties imposed upon the Physician Manpower Training Commission  
13 by law.

14 SECTION 34. There is hereby appropriated to the Physician  
15 Manpower Training Commission from any monies not otherwise  
16 appropriated from the Special Cash Fund of the State Treasury the  
17 sum of Four Hundred Thousand Dollars (\$400,000.00) or so much  
18 thereof as may be necessary to perform the duties imposed upon the  
19 Physician Manpower Training Commission by law.

20 SECTION 35. There is hereby appropriated to the Board of  
21 Trustees of the Oklahoma School of Science and Mathematics from any  
22 monies not otherwise appropriated from the General Revenue Fund of  
23 the State Treasury for the fiscal year ending June 30, 2020, the sum  
24 of Six Million Two Hundred Eighty-four Thousand Seven Hundred Sixty-

1 four Dollars (\$6,284,764.00) or so much thereof as may be necessary  
2 to perform the duties imposed upon the Board of Trustees of the  
3 Oklahoma School of Science and Mathematics by law.

4 SECTION 36. There is hereby appropriated to the Oklahoma Center  
5 for the Advancement of Science and Technology from any monies not  
6 otherwise appropriated from the General Revenue Fund of the State  
7 Treasury for the fiscal year ending June 30, 2020, the sum of  
8 Fourteen Million Three Hundred Seventy-one Thousand Three Hundred  
9 Ninety-eight Dollars (\$14,371,398.00) or so much thereof as may be  
10 necessary to perform the duties imposed upon the Oklahoma Center for  
11 the Advancement of Science and Technology by law. Of those funds

22 SECTION 84. There is hereby appropriated to the Department of  
23 Labor from any monies not otherwise appropriated from the General  
24 Revenue Fund of the State Treasury for the fiscal year ending June

1 30, 2020, the sum of Two Million Six Hundred Thirty-eight Thousand  
2 Six Hundred Ninety-three Dollars (\$2,638,693.00) or so much thereof  
3 as may be necessary to perform the duties imposed upon the  
4 Department of Labor by law.

5 SECTION 85. There is hereby appropriated to the Department of  
6 Labor from any monies not otherwise appropriated from the Special  
7 Occupational Health and Safety Fund for the fiscal year ending June  
8 30, 2020, the sum of Nine Hundred Fifty Thousand Dollars  
9 (\$950,000.00) or so much thereof as may be necessary to perform the  
10 duties imposed upon the Department of Labor by law.

11 SECTION 86. There is hereby appropriated to the Department of  
12 Labor from any monies not otherwise appropriated from the Special  
13 Occupational Health and Safety Fund for the fiscal year ending June  
14 30, 2018, the sum of One Hundred Thirty-eight Thousand Six Hundred  
15 Twelve Dollars (\$138,612.00) or so much thereof as may be necessary  
16 to perform the duties imposed upon the Department of Labor by law.

17 SECTION 87. Of the funds appropriated in Sections 84, 85 and 86  
18 of this act, a maximum of One Million Two Hundred Seventy-five  
19 Thousand Dollars (\$1,275,000.00) may be transferred to the  
20 Department of Labor Revolving Fund created by Section 141.19 of  
21 Title 40 of the Oklahoma Statutes, to be expended in accordance with  
22 law.

23 SECTION 88. There is hereby appropriated to the Department of  
24 Mines from any monies not otherwise appropriated from the General

5 SECTION 89. There is hereby appropriated to the Oklahoma

7 appropriated from the General Revenue Fund of the State Treasury for  
8 the fiscal year ending June 30, 2020, the sum of Nineteen Million  
9 Two Hundred Thirty-two Thousand One Hundred Ninety-eight Dollars  
10 (\$19,232,198.00) or so much thereof as may be necessary to perform  
11 the duties imposed upon the Oklahoma Tourism and Recreation

12 or so much thereof as may be necessary to perform the duties imposed  
13 upon the Alcoholic Beverage Laws Enforcement Commission by law.

15 Corrections from any monies not otherwise appropriated from the  
16 General Revenue Fund of the State Treasury for the fiscal year  
17 ending June 30, 2020, the sum of Five Hundred Fifty-three Million

19 (\$553,418,360.00) or so much thereof as may be necessary to perform

20 Bureau of Narcotics and Dangerous Drugs Control from any monies not  
21 otherwise appropriated from the General Revenue Fund of the State  
22 Treasury for the fiscal year ending June 30, 2020, the sum of Three  
23 Million Two Hundred Seventy-six Thousand Three Hundred Eighty-five  
24 Dollars (\$3,276,385.00) or so much thereof as may be necessary to

1 perform the duties imposed upon the Oklahoma State Bureau of  
2 Narcotics and Dangerous Drugs Control by law.

3 SECTION 100. There is hereby appropriated to the Department of  
4 Public Safety from any monies not otherwise appropriated from the  
5 General Revenue Fund of the State Treasury for the fiscal year

7 Seventeen Thousand Seven Hundred Ninety Dollars (\$77,117,790.00) or

10 SECTION 101. There is hereby appropriated to the Department of

6 thereof as may be necessary to perform the duties imposed upon the  
7 Office of the Attorney General by law.

8 SECTION 104. There is hereby appropriated to the Office of the  
9 Attorney General from any monies not otherwise appropriated from the  
10 General Revenue Fund of the State Treasury for the fiscal year  
11 ending June 30, 2020, the sum of Nine Hundred Ninety-nine Thousand  
12 Three Hundred Fifty-two Dollars (\$999,352.00) to transfer to the  
13 Legal Services Revolving Fund, created pursuant to subsection G of

22 (\$2,000,000.00) or so much thereof as may be necessary to complete  
23 repairs and maintenance of the Governor's Mansion.

1 SECTION 131. There is hereby appropriated to the Maintenance of  
2 State Buildings Revolving Fund (Fund 283) from any monies not  
3 otherwise appropriated from the General Revenue Fund of the State  
4 Treasury for the fiscal year ending June 30, 2020, the sum of Six  
5 Million One Hundred Thousand Dollars (\$6,100,000.00) or so much  
6 thereof as may be necessary to implement the provisions set forth in  
7 Section 908 of Title 62 of the Oklahoma Statutes.

8 SECTION 132. There is hereby appropriated to the Multiple  
9 Injury Trust Fund from any monies not otherwise appropriated from  
10 the General Revenue Fund of the State Treasury for the fiscal year  
11 ending June 30, 2020, the sum of Five Million Dollars  
12 (\$5,000,000.00) or so much thereof as may be necessary to pay  
13 obligations of the Fund.

14 SECTION 133. Sections 122 through 124 of this act shall become  
15 effective June 15, 2019.

16 SECTION 134. Sections 1 through 115 and 125 through 132 of this  
17 act shall become effective July 1, 2019.
