15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. There is hereby appropriated to the Oklahoma Opioid
17 Abatement Revolving Fund created pursuant to Enrolled House Bill No.
18 4138 of the 2nd Session of the 57th Oklahoma Legislature from any
19 monies not otherwise appropriated from the Opioid Lawsuit Settlement
20 Fund (Fund 383) of the State Treasury, the sum of Ten Million Two
21 Hundred Twenty Thousand Dollars (\$10,220,000.00) to be budgeted and
22 expended in accordance with law.
