15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. There is hereby appropriated to the Oklahoma Tourism  
17 and Recreation Department from any monies not otherwise appropriated  
18 from the Oklahoma Tourism Capital Improvement Revolving Fund (267  
19 Fund) the sum of Five Hundred Eight Thousand Thirty-one Dollars  
20 (\$508,031.00) or so much thereof as may be necessary to implement  
21 the provisions of Enrolled House Bill No. 2753 of the 2nd Session of  
22 the 57th Oklahoma Legislature.
