11 An Act relating to the Oklahoma Historical Society;  
12 requiring no less than certain amount of certain  
13 funds be used for certain purpose; providing for  
14 lapse of funds under certain conditions; requiring  
15 certain budget procedures; and prohibiting certain  
16 budget procedures.

17 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

18 SECTION 1. From the funds appropriated to the Oklahoma  
19 Historical Society in Enrolled Senate Bill No. 1922 of the 2nd  
20 Session of the 57th Oklahoma Legislature, not less than Four Hundred  
21 Ten Thousand Dollars (\$410,000.00) shall be used to offset revenue  
22 losses among the museums.

23 SECTION 2. Appropriations made to the Oklahoma Historical  
24 Society by Enrolled Senate Bill No. 1922 of the 2nd Session of the  
57th Oklahoma Legislature, not including appropriations made for

1 capital outlay purposes, may be budgeted for the fiscal year ending  
2 June 30, 2021 (hereafter FY-21) or may be budgeted for the fiscal  
3 year ending June 30, 2022 (hereafter FY-22). Funds budgeted for FY-  
4 21 may be encumbered only through June 30, 2021, and must be  
5 expended by November 15, 2021. Any funds remaining after November  
6 15, 2021, and not budgeted for FY-22, shall lapse to the credit of  
7 the proper fund for the then current fiscal year. Funds budgeted  
8 for FY-22 may be encumbered only through June 30, 2022. Any funds  
9 remaining after November 15, 2022, shall lapse to the credit of the  
10 proper fund for the then current fiscal year. These appropriations  
11 may not be budgeted in both fiscal years simultaneously. Funds  
12 budgeted in FY-21, and not required to pay obligations for that  
13 fiscal year, may be budgeted for FY-22, after the agency to which  
14 the funds have been appropriated has prepared and submitted a budget  
15 work program revision removing these funds from the FY-21 budget  
16 work program and after such revision has been approved by the Office  
17 of Management and Enterprise Services.
