11 An Act relating to the Oklahoma Department of
12 Corrections; authorizing certain lease payments;
13 authorizing the expenditure of certain funds in
14 certain amounts for certain purposes; and requiring
15 certain budgeted funds be expended for certain
16 purpose.

17 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

18 SECTION 1. From the funds appropriated to the Oklahoma
19 Department of Corrections in Sections 102 through 105 of Enrolled
20 Senate Bill No. 1922 of the 2nd Session of the 57th Oklahoma
21 Legislature, the Department of Corrections is hereby authorized to
22 make lease payments related to the North Fork Correctional Center.

23 SECTION 2. Of the funds budgeted for the offender management
24 system during the fiscal year ending June 30, 2020, the Department

1 of Corrections is hereby authorized to expend One Million One
2 Hundred Fifty-two Thousand Eight Hundred Seventy-one Dollars
3 (\$1,152,871.00) for the equalization of employee pay scales within
4 contracted private correctional facilities.

5 SECTION 3. From the funds appropriated to the Oklahoma
6 Department of Corrections in Sections 102 through 105 of Enrolled
7 Senate Bill No. 1922 of the 2nd Session of the 57th Oklahoma
8 Legislature, the Department of Corrections is hereby authorized to
9 expend One Million Six Hundred Sixty-one Thousand Six Hundred
10 Ninety-nine Dollars (\$1,661,699.00) for employee pay raises
11 authorized in Enrolled Senate Bill No. 1424 of the 2nd Session of
12 the 57th Oklahoma Legislature.

13 SECTION 4. From the funds appropriated to the Oklahoma
14 Department of Corrections in Sections 102 through 105 of Enrolled
15 Senate Bill No. 1922 of the 2nd Session of the 57th Oklahoma
16 Legislature, the Department of Corrections is hereby authorized to
17 expend Six Million Dollars (\$6,000,000.00) for hepatitis C
18 treatment.

19 SECTION 5. From the funds appropriated to the Oklahoma
20 Department of Corrections in Sections 102 through 105 of Enrolled
21 Senate Bill No. 1922 of the 2nd Session of the 57th Oklahoma
22 Legislature, the Department of Corrections is hereby authorized to
23 expend Twenty-nine Thousand Two Hundred Thirteen Dollars
24 (\$29,213.00) for the annualization of teacher pay increase
