10 COMMITTEE SUBSTITUTE

11 An Act relating to the Military Department of the  
12 State of Oklahoma; requiring that portions of certain  
13 appropriated funds be used for certain purposes;  
14 providing for lapse of funds; requiring certain  
15 budget procedures; and prohibiting certain budget  
16 procedures.

17 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

18 SECTION 1. From the funds appropriated to the Military  
19 Department of the State of Oklahoma in Enrolled Senate Bill No. 1922  
20 of the 2nd Session of the 57th Oklahoma Legislature, not less than  
21 Two Million Dollars (\$2,000,000.00) shall be used to provide for  
22 flood remediation and other deferred maintenance. These funds shall  
23 be used to provide additional funding for flood remediation and  
24 other deferred maintenance and shall be used to supplement rather  
than replace existing resources.

1 SECTION 2. Appropriations made by Enrolled Senate Bill No. 1922  
2 of the 2nd Session of the 57th Oklahoma Legislature, not including  
3 appropriations made for capital outlay purposes, may be budgeted for  
4 the fiscal year ending June 30, 2021 (hereafter FY-21), or may be  
5 budgeted for the fiscal year ending June 30, 2022 (hereafter FY-22).  
6 Funds budgeted for FY-21 may be encumbered only through June 30,  
7 2021, and must be expended by November 15, 2021. Any funds  
8 remaining after November 15, 2021, and not budgeted for FY-22, shall  
9 lapse to the credit of the proper fund for the then current fiscal  
10 year. Funds budgeted for FY-22 may be encumbered only through June  
11 30, 2022. Any funds remaining after November 15, 2022, shall lapse  
12 to the credit of the proper fund for the then current fiscal year.  
13 These appropriations shall not be budgeted in both fiscal years  
14 simultaneously. Funds budgeted in FY-21, and not required to pay  
15 obligations for that fiscal year, may be budgeted for FY-22, after  
16 the agency to which the funds have been appropriated has prepared  
17 and submitted a budget work program revision removing these funds  
18 from the FY-21 budget work program and after such revision has been  
19 approved by the Office of Management and Enterprise Services.
