16 Section 661.1), is amended to read as follows:

17 Section 661.1 A. Except as provided in subsection B of this
18 section, all positions of the Office of the Secretary of State are
19 subject to the Merit System of Personnel Administration.

20 B. The following positions of the Office of the Secretary of
21 State shall be in the unclassified service:

- 22 1. The Secretary of State;
- 23 2. The Assistant Secretary of State;
